CALL TO ORDER

The PUBLIC HEARING meeting of the Village of Candor Board of Trustees began at 6:30 pm with the Pledge of Allegiance and was called to order by the Honorable Mayor Eric Halstead on July 19, 2016 at the Village Hall, 138 Main Street, Candor, NY.

<u>Fire Commission/Company Agreement Update</u> – Mayor Halstead reviewed the specifics of the agreement between the Village of Candor and the Fire Commission/Company. Discussion followed.
